1. Applications are invited from the eligible candidates for filling up of various categories of posts in State Programme Management Unit and STDC under NHM , AP.

3. Age limits: 18-45 years as on date of issue of notification.
4. Candidates shall submit their application in online and upload the following documents :

 - h. Copy of Experience certificate as per column 4 of annexure II
 - i. Copy of PH Certificate/ Ex Serviceman Certificate, if applicable.
